Dear FEC Analyst,

On May 19<sup>th</sup>, your FEC Division sent a letter to me, Ryan Stephen Ehrenreich (FEC Candidate ID# P00011395), instructing me to submit a bank account number for funds tied to my Campaign Committee (FEC Committee ID# C00703512). Your letter also stated failure to do so could result in audit.

Today, June 17<sup>th</sup>, I called the FEC phone number specified in your letter (1-800-424-9530) and spoke to an FEC Analyst about this letter, my specific situation, and how to resolve this matter as simply as possible.

I started by explaining that I am poor, I can barely afford my own living expenses, and so I do not have the thousands of dollars of funds necessary to establish a Legal Entity for my Campaign Committee under California Law. However, establishing such an Entity is a common prerequisite for opening a bank account in my Campaign Committee's name.

I further explained that I do not plan to raise money or spend funds on my campaign. Currently, I campaign through conversations on Twitter & Facebook, which do not cost anything. I do not expect this to change in the foreseeable future.

Your Analyst stated that since I will be under the \$5,000 threshold that triggers reporting requirements, I should send a letter via USPS Certified Mail to your office explaining this and requesting an exemption to the Rule 11 CFR § 103.2.

I hope that you understand my unique circumstances and grant me such an exemption. If I do not receive an exemption, I fear the required cost associated with establishing such a bank account may preclude me from paying rent or covering other necessary living expenses.

Please keep me updated as to the status of this matter and thank you in advance for your efforts on my behalf.

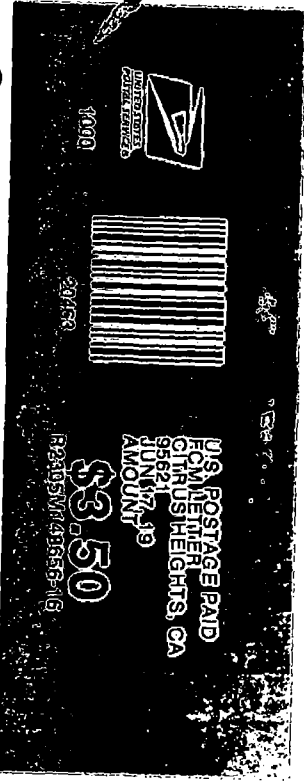

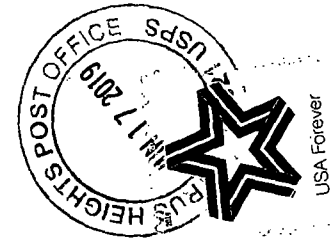
