Dear FEC Analyst,

As the first quarter of 2022 is drawing to a close, I offer the FEC the following update on the status of my 2024 U.S. Presidential Campaign.

Based on the urgency of the situation in Ukraine, I have mainly campaigned on Twitter, offering specific proposals for how to address the Russian invasion of Ukraine. I have also offered forward-looking proposals in regards to Taiwan, should such proposals prove necessary in the future.

For Ukraine, I have stated that we (the U.S. and NATO) should have had in place an emergency plan to admit Western Ukraine into NATO as soon as Russia launched its military invasion. In this plan, the state of Western Ukraine should not share any land borders with Russia. Rather the part of Ukraine that does border Russia should be sectioned off into Eastern Ukraine and should still be claimed by Western Ukraine, with the caveat that many parts of Eastern Ukraine have been illegitimately occupied by Russia. Given the Russian military invasion of Ukraine has already started, so as to still gain the value of this plan in the status quo, I have proposed a NATO-backed No-Fly-Zone over Western Ukraine (but NOT Eastern Ukraine) and a NATO-like commitment of support to Western Ukraine. For Taiwan, I have proposed the formation of an organization similar to NATO in the Asian-Pacific, which shall initially NOT include Taiwan. However, if China were to attempt an invasion of Taiwan, I propose immediately recognizing Taiwan as a sovereign country and admitting Taiwan into this Asian-Pacific treaty organization. I also propose meeting any Chinese invasion force with an allied force of equal or greater size prior to the invasion force landing. I am, however, submitting this letter to document my campaign status.
